Hypocrisy in Government

Johnson & Johnson

Johnson & Johnson knew for decades that asbestos lurked in its Baby Powder

A Reuters examination of many of those documents, as well as deposition and trial testimony, shows that from at least 1971 to the early 2000s, the company's raw talc and finished powders sometimes tested positive for small amounts of asbestos, and that company executives, mine managers, scientists, doctors and lawyers fretted over the problem and how to address it while failing to disclose it to regulators or the public.

The documents also depict successful efforts to influence U.S. regulators' plans to limit asbestos in cosmetic talc products and scientific research on the health effects of talc.

New census figures showing aging population pose future problems for Canada, experts warn

More people are retiring than entering the workforce and the latest census figures show that gap will only grow in the coming years — a trend some experts warn will put a strain on services like health-care and housing and won't be entirely solved by immigration.

"The trouble is, is that when you get into birth rates that are as low as ours ... you really can't overcome that deficit through immigration."

"If you have a profound labour scarcity, you cannot fill the jobs that are needed ... You cannot effectively provide services," she told CBC News.

"It boggles my mind because we've known the data for a long time, we knew what was ahead of us, I just think we always decide to prioritize other populations and other needs earlier," Sinha said.

Our aging population - a serious problem for Canada

Canadians are living longer than they ever have. Sixty years ago, life expectancy (at birth) was only 68.3 years for men and 74.2 years for women. By 2018, life expectancy had increased at least another 10 years for both genders. And long-term projections suggest this trend of increasing life expectancy will continue into the future. For children born in 2068, life expectancy could reach 87.0 years for males and 89.0 years for females.

At the same time, however, Canadians are having fewer children than they did decades ago, helping slow population growth in the country. All indications point towards this continuing for the foreseeable future, notwithstanding proposed increases in government immigration targets.

Phasing out coal, a feverish pursuit of green energy, new tax regimes — where have we heard all this before?

Butts has graduated to the halls of Parliament Hill as Prime Minister Justin Trudeau's own principal secretary, leaving behind a province still paying the price, literally, for his tenure. His promise to eliminate coal, for example — a worthy gambit, if done fiscally responsibly— cost Ontario consumers an extra \$37 billion between 2006 and 2014, according to an auditor general, and is expected to cost another \$133 billion from 2015 to 2032.


Boondoggle: How Ontario's pursuit of renewable energy broke the province's electricity system

Essential Student Debt Statistics


The number of students taking loans rose from practically zero in the 1960s to more than 1.7 million in 2017.

This rise has far-reaching consequences – for instance, student debt in ON is slowly getting out of hand. In 2018, one in six insolvencies in the whole of Ontario was signed by student debtors. Also, in 2018, extrapolations showed that more than 22,000 ex-students across Canada filed for insolvency.

Recent student debt in Canada statistics reveal that 51% of students doubt they will be able to pay next year's tuition.

The average time to pay off student loans in Canada is between 9 and 15 years.

"This is one of the biggest financial frauds in American history," said Damian Williams, U.S. attorney for the Southern District of New York, wearing the starched demeanour of a federal prosecutor.

"It's really unprecedented, in terms of lack of documentation," said Ray, who gained stature untangling the financial wreckage of Enron, the bankrupt energy trader. "Literally, there's no record-keeping whatsoever."

"This isn't sophisticated whatsoever," Ray concluded of the alleged fraud. "This is just plain old embezzlement. Old school."
