

The Fall of Jerusalem – The Rise of Palestine

I. Setting the Stage

After centuries of prophecy, warning, and rebellion, the Jewish nation faced its final collapse under Roman rule. What began as a series of revolts ended in national destruction, scattering, and renaming—a calculated attempt to erase Israel’s identity from the earth.

Luke 21:24

“They will fall by the edge of the sword and be led captive among all nations, and Jerusalem will be trampled underfoot by the Gentiles...”

II. The First Jewish Revolt (AD 66–70)

Background:

Years of Roman oppression, heavy taxation, and Jewish nationalism erupted into open revolt. Zealots and rebel factions fortified Jerusalem, expecting divine deliverance.

Siege of Jerusalem:

Roman general **Titus** (son of Emperor Vespasian) surrounded the city. Famine, civil war, and brutality tore the city apart from within.

In **AD 70**, Roman legions **burned Jerusalem, destroyed the Temple, and ended Jewish political independence.**

Fulfillment of Prophecy:

Matthew 24:2 – “Not one stone will be left upon another.”

Daniel 9:26 – “The people of the prince who is to come shall destroy the city and the sanctuary.”

Result:

Jerusalem lay in ruins. The Temple—the heart of Jewish worship—was gone. Survivors were enslaved or dispersed throughout the empire.

III. The Second Revolt: Bar Kokhba (AD 132–135)

The Final Blow:

Sixty years later, a messianic leader named **Simon Bar Kokhba** led another uprising against Rome. For three years, the Jews regained brief control—but Emperor **Hadrian** retaliated with overwhelming force.

Aftermath:

- **Hundreds of thousands** of Jews killed
 - Survivors **enslaved** or scattered
 - Jews **banned** from entering Jerusalem on pain of death
 - City **renamed Aelia Capitolina** (“Hadrian’s City,” dedicated to **Jupiter**)
 - The province **renamed Syria Palaestina**, recalling Israel’s ancient enemies, the **Philistines**

IV. The Erasure of Israel’s Identity

These were **not accidental renamings**—they were **deliberate acts of cultural and religious extermination**. Rome sought to erase every trace of the Jewish nation from geography, history, and memory.

UN Genocide Convention (1948):

“Acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group.”

By this definition, Rome’s campaign was a form of **ancient genocide**—not just military conquest, but a total **erasure of identity**.

V. The Dispersion and Its Legacy

- Jews dispersed across the Roman Empire—Europe, Africa, and Asia.
- National sovereignty lost for nearly **1900 years**.
- **Persecution** became a constant theme in Jewish history.
- **Believers** saw these events as divine confirmation of Christ’s prophecy in **Luke 21** and **Matthew 24**.

Deuteronomy 28:64 – “The LORD will scatter you among all peoples, from one end of the earth to the other...”

VI. The Rise of “Palestine”

When Rome renamed Judea as **Syria Palaestina**, the intent was clear:

- To **mock Jewish heritage**, replacing “Israel” with the name of its **ancient enemies**.
 - Over time, the name “Palestine” became attached to the region and persisted through history
 - Today, the name carries **political and ideological weight**—but its **origin** was of **erasure**, not identity.

VII. Common Misunderstandings Today

Modern media often uses “Palestine” as if it were a continuous, ancient national identity.

In truth, it was a **Roman invention**, imposed after the **genocidal destruction** of the Jewish people.

This misunderstanding shapes much of today’s political dialogue—yet the biblical and historical roots tell a very different story.

VIII. Reflection for us as Believers

Even amid destruction, God’s purpose continued:

- Israel’s fall made way for the **Gospel to go to the nations (Romans 11:11)**.
- The loss of the Temple shifted worship from **ritual to spirit and truth (John 4:23)**.
- The “times of the Gentiles” began, awaiting return of the Lord Jesus Christ and the **restoration of Israel**.

Romans 11:26 – “And so all Israel shall be saved...”
